

**PARENT / GUARDIAN
DECLARATION
2-4 OCTOBER 2009**



1. I/We of (address)are the parent(s) or legal guardian(s) of (name)("Minor"). The Minor wishes to volunteer for the **Lobethal Grand Carnival 2009** ("Event") conducted by **Vintage Motorsport Carnivals Pty Ltd** ("Organiser").

I/We consent to the Minor's involvement and participation in the Event.

2. I/We acknowledge that motorsport is dangerous and that by engaging in the sport and being involved with the Event the Minor, takes and is exposed to certain risks and dangers including that:
- (a) the Minor may be injured, physically or mentally, and may be killed;
 - (b) the Minor's property may be damaged, lost or destroyed;
 - (c) track or Event conditions may be hazardous and may vary without warning or predicability;
 - (d) the Organisers, officials, landowners and any agents or representatives of those in charge of the Event are frequently obliged to make decisions under pressure of time and/or events;
 - (e) any policy of insurance of or in respect of the Minor's life or physical or mental health may be voided;
 - (f) there may be no or inadequate facilities for treatment or transport of the Minor if injured; and
 - (g) persons including the Minor have an obligation to themselves and to others to be involved safely and within the rules, policies and procedures of the Event.

3. In consideration of the Organiser's accepting the Minor as a volunteer in the Event I/We agree to indemnify the Organisers and each of them in the following manner:
- (a) that the Minor being involved in the Event at my/our sole risk and responsibility;
 - (b) that the Minor accepts the venue as it stands with all or any defects hidden or exposed;
 - (c) that I/We indemnify and hold harmless the Organisers, their respective servants, agents or officials against any actions or claims which may be made by the Minor or on his behalf or by other parties for or in respect of or arising out of the Minor's death or any injury loss or damage caused to the Minor whether caused by negligence, breach of contract or in any other manner whatsoever.
4. I/We release & forever discharge the Organisers from all Claims that I may have or may have had but for this release arising from or in connection with this document or from the Minor's involvement in the Event.

5. I/We declare that the Minor is medically and physically fit and able to be involved with the Event.

6. I/We authorise the Organisers to administer or have administered to the Minor such medical treatment as may be required to treat any injury, damage or loss that the Minor may suffer as a result of involvement with the Event.

7. I/We authorise the Organisers to direct the Minor not to be involved in the Event if involvement constituted an unacceptable risk of causing the Minor harm, injury or death.
